This is truly a great asset to have and plans are underway to renovate the older pavilion

We also benefited this past year with the new emergency generators. There have been power outages that went unnoticed because the generators immediately started and provided the building with full replacement energy. What an improvement over the very limited emergency generators we had for so many years.

Major improvements continue to our building. We currently have the Nurse Call Bell replacement project underway which should be completed before the year ends. Other projects that are approved and moving forward include: replacement of the fire alarm system; replacement of a major portion of the metal roofing; replacement of two large roof-top air conditioning units; installation of circulating water system filters.

But, as important as anything else, our donors and volunteers still continue to do tremendous things. Volunteer hours have already exceeded 12,000 for the year to date. Where would we be without the support we get from such dedicated individuals and groups? We continue to be blessed with such an outpouring of support.

# **MDICS**

Charlotte Hall Veterans Home is pleased to announce our partnership with MDICS, a Maryland-based Medicare-certified provider group that is experienced with taking care of patients in hospitals, skilled nursing/rehabilitation, long-term care centers as well as residents in assisted living communities. MDICS is honored to join CHVH as its preferred health care provider.

### **MDICS Services**

- An MDICS provider will see you/your loved one and review the plan of care as often as needed based on your you/your loved one's diagnosis and medical condition.
- On-site medical services include a thorough initial medical evaluation (history & physical, assessment of medications, lab work, diagnostic tests), monthly follow-up visits (medical condition may warrant more frequent visits), and performing necessary tests to diagnose and treat your loved one's medical conditions.
- MDICS provides care coordination and communicates with specialists as well as the Charlotte Hall clinical team. In addition, the providers are available for family meetings and will address concerns upon request.
- The MDICS provider team is on-call (available by phone) for Charlotte Hall residents 24 hours a day, 7 days per week.

# Department Spotlight: Social Services

#### Social Services and Resident Services:

Charlotte Hall Veterans Home provides social services to both Skilled Nursing Facility Residents and Assisted Living Residents. In the Nursing Facility, the Director of Social Services oversees four Case Managers, who cover seven units. In Assisted Living, the Director of Resident Services oversees a Case Manager and a Mental Health Counselor, who cover four units. The Director of Resident Services also supervises our Recovery Support Counselor who works with Residents from the entire building.

The services provided to our Residents vary from day to day and cover a wide variety of areas, including but not limited to: assisting Residents with legal paperwork, such as completing an Advance Directive or designating a Financial Power of Attorney; conducting cognitive, psychosocial, and mental health assessments; scheduling and participating in family meetings; taking care of dental and optometry needs; acting as a liaison between the Residents and other Departments; and working closely with nursing and physicians

to ensure our Residents needs are being met.
Our most important job though is to advocate for our Residents' and to be their support when they need it most.

#### **Behavior Forum:**

The 5th Behavior
Forum is scheduled to
take place on Friday, No-

vember 21, 2014, and will be presented by Renee Nordstrom, CDP, Mental Health Counselor, and Maura Pieper, MSW, Director of Resident Services. The Behavior Forum began in May 2012 as a way to draw together staff of various departments from both CHVH and other HMR facilities, as well as contracted employees, to discuss and create ideas on how to meet the psychosocial and mental health needs of the ever-changing population of our Veterans. Topics that have been discussed include how to empower our frontline employees, how to offer activities that vary to meet the needs of all ages,

and how to manage behaviors in the long term care setting.

A different approach is being taken with the upcoming Behavior Forum. This Forum has been opened up to both community and VA healthcare providers. They have been invited to participate in a round table discussion to discuss the psychiatric needs of our Veterans and how we, as healthcare providers, can work together to make certain that our Veterans are receiving the best quality of care. We look forward to establishing stronger connections with our outside providers to ensure the continuum of care is being met.

Heather is an occupational therapist and dementia care specialist who provides training for professional and family caregivers. She offers services to indi-

viduals with aging issues and provides consultations with facilities on topics related to Dementia and Alzheimer's care. With each presentation, Heather equips the audience with a wealth of knowledge and with practical techniques for caregivers to utilize when working with their residents and/or loved one(s). She does this in a fun, interactive style that gives caregivers a positive approach to apply immediately to interactions with persons with dementia.

In 2007, Heather received the Marlys Mitchell Pioneer Award for humanitarian values, knowledge, and visionary leadership. She is a recognized trainer for the Alzheimer's Association and is a member of Dementia Care Professionals of America. In 2008, Heather collaborated with the National Association of State Veterans' Homes and the Armed Forces Veterans' Homes Foundation to produce the caregiver training video series, Dementia Care for America's Heroes. Currently, Heather is the OT and Dementia Care Program Manager for Hospice of Alamance-Caswell and Life Path Home Health and serves families and individuals with dementia in their own homes in the Alamance-Caswell community.

# Why select Charlotte Hall Veterans Home?

- We are the only state Veterans home in Maryland.
- being in State Veterans Home, and through a partnership between the US Department of Veterans Affairs and the Maryland Department of Veterans Affairs, veterans are eligible to receive a daily stipend to apply towards their cost of care. The current USDVA per diem rates are \$102.38 per day for nursing home care and \$44.19 per day for assisted living care. Needless to say, this enables veterans and their families to save significantly.
- Quality of Care 5-Star Facility & Extraordinary Staff: CHVH works closely with the Maryland Department of Veterans Affairs (MDVA) to ensure the facility is constantly updated to provide the best care for veterans and their spouses. The CHVH staff understands and respects the sacrifices veterans have made and "serving those who served" is our mission, something only experienced in Maryland at CHVH.
